

Greater Indiana Masters Swimming (GRIN) Short Course State Championship Bid Application



*Bids open every year on **September 1** and must be received by **October 1**, at 8:00 p.m. EDT with the winning bid announced by **November 1**. The bid will reopen for the month of November (deadline December 1), in the event there are no bids or there is no qualifying bid. A final decision in that case will be made before the end of the calendar year. The Northern 1/3rd of the state will have preference for the 2023 bid year.*

Greater Indiana Masters Swimming is soliciting bids for the **2023 GRIN State Championship Meet**. For the 2023 bid year, the bid will be open to: the Northern third of the state. For future years, the rotation will be posted at grinswim.org. Participants pay entry fees for the GRIN State Meet and this revenue is passed to the meet hosts making it a rewarding experience for the host team. Meet hosts are encouraged to set a reasonable fee because the meet host will be guaranteed at least \$5,000 (the stipend approved by the board) to offset expenses. Even if your club does not have the desire or facility to host the Championship meet, we encourage you to reach out to local age group and high school swim programs, colleges, and YMCAs to let them know of this opportunity. After all, wouldn't you prefer the Championship meet in your own back yard than somewhere else?

The GRIN State Championship Meet should be held after March 1. A Saturday/Sunday format is encouraged; however, we will accept a Friday/Saturday format as well for this 2-day event. Please fill out the bid form and *submit by the deadline on the first page of the bid packet*. Attachments to the bid form, such as logos, sample budgets and pertinent event details, are not required but will be considered. Pool-length certification, if not already on file, must be submitted within two weeks of the bid. All submissions should be emailed to the GRIN Chair with information at the bottom of this page by October 1.

You will receive an email response acknowledging confirmation that your bid form was received. Please follow up if you do not receive an email confirmation within 24 hours.

Bids will be reviewed by our committee and winners will be selected on or about the middle of November. Selection of the winning bid will be based on the overall suitability of the bid received. Bids received after October 1 may not be considered if a qualified, timely bid has already been received unless the bidding has been extended by the GRIN BOD.

The timing of the GRIN Annual Board Meeting will be announced at least 30 days prior to the event but commonly takes place about the middle of the Saturday events. An alternative would be during the Saturday evening social hosted by GRIN.

Obligations of the Host:

In the event that Greater Indiana Masters Swimming awards the GRIN Short Course State Championship to our organization, we agree to all the Terms and Conditions set forth in this agreement. In the event that we are unable to perform any of these duties after the meet is awarded, we will notify GRIN as soon as possible and understand that financial penalties may be levied.

Obligations of the GRIN Bid Committee:

The GRIN Bid Committee shall designate a liaison to provide assistance and guidance necessary to provide for uniformity in the conduct of the GRIN Short Course State Championship Meet. This shall include communications during the months prior to the meet and attendance at the meet. GRIN will be responsible for collecting entries for the meet, and downloading event files, but the meet host is responsible for running the actual event.
